REGULATIONS ON NJUPT INTERNATIONAL STUDENTS' OFF-CAMPUS ACCOMMODATION

According to Immigration regulations and requirements of related functional departments concerning foreigners' accommodation management, School of Overseas Education of NJUPT now decide to implement verification and registration regime for international students who apply for off-campus living.

I. Qualifications

International students currently in school who satisfies any of the following requirements can apply for living outside the NJUPT campus with supporting proof documents:

- 1. Both husband and wife are currently staying in Nanjing.
- 2. Have lived in Nanjing over half a year or any other city in China for at least one year on the date applying for living off-campus.
- 3. Have studied in NJUPT for at least one year with good academic performances (for undergraduates accumulated GPA should exceed 2.8; for graduates the average of accumulated scores should exceed 80 points; calculate using grades from the former academic year), and with attendance rates exceeding 80% (calculate using attendance rates from the former academic year); furthermore applicants should have no record of warning or punishment.

II. Registration in the School of Overseas Education

1. International students who apply for off-campus living must come to advisors' office to register with following materials;

The lease agreement

(Master students need to go to your supervisor for approval before you sign a contract with the landlord.)

Copy of house-owner's identity card (from house-owner)

Application Form of Applying for Living Off Campus for International Students from School of Overseas Education in NJUPT (from advisors' office)

- 2. After finishing the registration, school will help international students update accommodation information and provide students certificates of off-campus living as well as waving their accommodation fees.
- 3. For registration, every time international students can apply for a one-year (academic year) off-campus accommodation. For every new academic year, international students should fill the application form, and school will check the qualifications for application again.

III. Registration in police stations

If international students have changed the address of residence, they are supposed to bring their passports, lease agreements and ID card (copy) of the landlords to check in for registration in the police stations where their lodgings belong to within 24 hours. The police stations then will write a receipt to the overseas personnel.

IV. Management of living off campus

For international students who are living off campus, they ought to promise the attendance to lectures and the campus as prescribed. At the same time, they should allow the police staff and NJUPT to executive security check occasionally.

As for the attendance to campus, students who live outside must observe the rules of registration, i.e., go to AYI for registration at the International Students Apartment at least once per week.

The checking results will then be calculated as dormitory scores in scholarship evaluation.

P.S. While off-campus living, students must abide by the law of the People's Republic of China and the regulations of NJUPT; Students are to bear all responsibilities for their own behavior, personal safety as well as property safety.
